# BEi Rental Policies

- Our insurance company requires that all renters show a valid OHIO driver's license.
  Out-of-state renters will be subject to a larger deposit.
- All renters will be charged a refundable security deposit that covers a daily rental or a cash amount equal to the total replacement cost of the equipment.
- We charge for time out, not time used.
- Rates do NOT include sales tax or 9% damage waiver.
- Customer is responsible for all negligent damage, losses, accidents, and/or theft.
- Loading and unloading is a courtesy, we are not responsible for damage.
- Weekly and 4 week rentals must be paid for up front, otherwise it's day by day.
- All prices are subject to change without notice. The price list will change over time; always call first for current pricing.
  We are not responsible for errors or changes.
- All equipment comes with a full tank of fuel and must be returned full, or a fuel service charge will apply.
- 4 hour and daily rates apply to open business hours only.
- Delivery and pickup available at reasonable rates, please ask.
- BEi is constantly adding to our rental inventory; if you don't see it, please ask.

# Your General Responsibilities

Under the BEi rental contract, you assume full responsibility for the loss of, destruction of, or damage to, the equipment while in your possession or control, or while in transit to or from any place of use or storage. You agree to pay BEi Supply & Rental in cash, the full value of the equipment in the event the equipment is



lost or destroyed, or for the full cost of the repairs if it is damaged.

You also agree to assume full responsibility for all personal injuries or property damage arising out of your use and possession of the equipment, and to defend, indemnify and hold BEi Supply & Rental harmless for any liability

for any such personal injuries and property damage



# Damage Waiver

When you pay the damage waiver through BEi, the proper indication, thereof on the front of the rental contract and payment of an additional sum equal to 9 percent of the gross rental charge, BEi waives your responsibility for accidental damage to the equipment while in your possession or control. You must still take precautions to protect the equipment and not intentionally damage the equipment.

#### Expectations

The damage waiver does not cover damage or loss caused by burglary theft, conversion, misuse, abuse, intentional or negligent damage or destruction, or similar causes will remain your responsibility including & without limitation:

- Use of/operation of equipment in a manner inconsistent with the manufacturer's instructions or rental agreement
- Loss or damage to the accessory equipment such as welding leads, electrical cords, bits, batteries, hoses, tires, tubes or harness, etc..
- Loss due to inventory shortage, wrongful conversation or dishonest act by the customer or by a person entrusted with the equipment
- Loss or damage due to flood, storm, earthquake or external factor
- Loss or damage due to overloading or exceeding capacity rate
- Seizure or destruction of the equipment
- All loss or damage caused by theft, vandalism or malicious mischief

# Environmental Value & Repair Costs

Cost of repairs shall be determined by BEi. Any loss or destruction shall mean the manufacturer's list price to the equipment shall be deemed destroyed if the cost of repairs exceeds the manufacturer's list price and equipment shall be deemed lost if the customer is unable to recover the equipment for a period of 30 consecutive days, You agree that your liability for the rentals for any lost, damaged or destroyed equipment shall continue until BEi has been paid in full for the damages mentioned above.

### Theft & Vandalism

The responsibility for rental equipment remains with the renter from time of receipt to time of return. Equipment left in the care of a third-party is still the responsibility of the renter. We ask you to take the necessary precautions to protect our equipment from theft, damage and inclement weather while in your possession. Lost, stolen or damaged items will be charged at replacement cost.

## NOTE:

The Damage Waiver is NOT insurance. You will still be responsible for any personal injury or propery damage as set forth in the rental contract or operation
